Spurious Drug Rackets Busted:

Drugs Control Administration, Telangana is maintaining a vigilant stance, actively monitoring and detecting the movement of spurious drugs within the State.

On the basis of intelligence gathered by Drugs Control Administration officials, several spurious drug rackets busted in Telangana. During the raids conducted between December-2023 and November-2024, spurious drugs worth Rs. 3.06 crores (from Dec-2023 to December-2024) seized. In the year 2024 alone, Spurious Drugs worth Rs. 2.36 Crores were seized.

Brief Details of Spurious Drug Rackets Busted:

- Seized huge quantities of spurious drugs including anticancer drugs etc. at an unlicensed godown at Machabollaram.
- Seized spurious drugs shipped to Hyderabad through the courier from Kashipur, Uttarakhand, falsely declared as parcels containing 'Machine Parts'

Spurious drugs falsely labeled under reputed companies include - Sun Pharma (Rosuvas 10 Tablets), Glenmark Pharma (Telma H Tablets, Telma 40 Tablets), Aristo Pharmaceuticals (Monocef-O 200 Tablets), Torrent Pharma (Chymoral Forte) and Spurious antibiotics labeled as manufactured by 'Meg Lifesciences, Sirmour, Himachal Pradesh,' a fictitious/non-existent company.

- Busted Spurious Drug Manufacturing: A manufacturer by name Rams Pharmaceuticals, located at Moosapet, Hyderabad, was found manufacturing spurious Anti Ulcer medicines in the name of a Punjab-based company without a valid drug license, under the guise of being a Food Supplement manufacturer.
- Inter-state Operation from 27th February to 29th February, 2024:
 Inter-state operation carried out by the Drug Control Administration, Telangana, Commissioner's Task Force,
 Hyderabad, and Malakpet Police.

This operation led to the busting of a 'Spurious Drug Manufacturing Unit' located in Kotdwar, Uttarakhand.

Nectar Herbs and Drugs, located in Kotdwar, Uttarakhand, was found to be manufacturing counterfeit drugs (spurious drugs) of reputed companies and distributing them to several states, including Telangana.

- In another joint operation with the Police Department in July-2024, a spurious drug manufacturing unit located in Doolapally, Medchal-Malkajgiri District, was also busted.
- On 22nd November, 2024, busted a Spurious Drug racket in Hyderabad involving the shipment of spurious antibiotic tablets from Prayagraj, Uttar Pradesh to Telangana through couriers.

Gandla Ramulu, a habitual offender involved in various spurious drug cases in the State, shipped the spurious antibiotics into Telangana from Uttar Pradesh with the assistance of Munishekhar, a resident of Proddutur, Andhra Pradesh. Spurious antibiotics worth **Rs. 6.91 lakhs** were seized.

On 26th November, 2024, DCA seized a huge stock of antibiotics worth Rs. 1.33 Crores from the manufacturing facility of Jodas Expoim Pvt. Ltd., located in Biotech Park, Karakapatla, Siddipet District, for exporting products manufactured by other pharmaceutical companies (Indian Genomix Pvt. Ltd., Cherlapally, Telangana and Zazen Pharma Pvt. Ltd, Palghar, Maharashtra) to Russia, falsely under their own name (i.e. of Jodas Expoim Pvt. Ltd.) and also for unauthorized packing of antibiotics.

Curbing the Abuse of Habit-Forming Drugs in the State:

- Curbing the abuse of habit-forming drugs in the State is of utmost priority to the Drugs Control Administration, Telangana. Every effort is being made to prevent the indiscriminate sale of such drugs within the State.
- The joint operation carried out by Drugs Control Administration,
 Telangana along with Prohibition & Excise Department, in March2024, successfully busted illegal manufacturing of the
 Psychotropic Substances 3-MMC & Alpha-PiHP.
- Stocks worth 11.32 Crores of psychotropic substances seized, in March-2024, during joint operations with Prohibition and Excise Department.
- In March-2024, DCA carried out a Joint operation with Police Department and Prohibition and Excise Department which led to busting of illegal diversion of Narcotic Drugs from Operation Theatre of a hospital in Jagtial. A doctor who illegally diverted Narcotic drugs from the Operation Theatre and sent them to Hyderabad through courier/parcel, thereby supplying them to a drug addict in Sainikpuri, was arrested.
- In July-2024, DCA conducted raids as part of a special drive concerning the illegal sale of habit-forming drugs, based on inputs from the Commissioner's Task Force, Hyderabad. The licences of

twenty medical shops in Hyderabad and Secunderabad zones were suspended, and the licence of one medical shop was cancelled by the Drugs Control Administration for the illegal sale of habit-forming drugs.

- On 30th October, 2024, Drugs Control Administration, Telangana carried out a joint operation along with Prohibition & Excise Department and busted a network involved in the illegal procurement, stocking, and sale of Narcotic Drugs and Psychotropic Substances by private hospitals in Hyderabad. Huge stocks of narcotic drugs and psychotropic substances seized. Neha Bhagwath, a habitual offender and three other accused were apprehended.
- In continuation to the raids, on 7th and 9th November, DCA carried out a joint operation along with Prohibition & Excise Department and busted illegal stocking and sale of Narcotic Drugs and Psychotropic Substances at certain private hospitals in Hyderabad.

NOT OF STANDARD QUALITY DRUGS – DRUGS CONTROL LABORATORY:

- ➤ Risk-based Sampling directions issued to the field officers in August-2023, publishing the **Risk indicators** to be considered for lifting of samples from the supply chain and from manufacturing facilities, which **significantly increased detection of sub-standard drugs** moving in the market.
- ➤ In the year **2023**, Drugs Control Laboratory reported **79 drugs** as Not of Standard Quality (NSQ) Drugs.

➤ In the year **2024** (till 20th December), Drugs Control Laboratory reported **130** drugs as Not of Standard Quality (NSQ) Drugs.

Apart from the above, DCA detected several other breaches of the Act including:

- Manufacturing of cytotoxic anticancer formulations along with other injectables
- > Mixing of ayurvedic drugs with allopathic drugs
- > Illegal sale of Oxytocin injections
- > Illegal sale of steroids and cardiac stimulant injections in gyms
- Procurement of large stocks of insulin injections without purchase bills
- > Unlicensed manufacturing of blood components
- > Illegal collection and storage of plasma
- > Illegal sale of habit-forming drugs
- Cases were registered against the offenders as per the provisions of the Drugs and Cosmetics Act.

Other Key Achievements – 2024:

Collaboration with United States Food and Drug Administration (US FDA):

- United States Food and Drug Administration (US FDA) proposed for "US FDA – Telangana DCA Regulatory Forum" for future strategic collaboration and initiatives, as Telangana State has about 200 USFDA registered manufacturing sites i.e. pharmaceutical companies that manufacture, export medicines to USA.
- 'First Annual Regulatory Forum' between USFDA and Drugs Control Administration, Telangana held on 31st January, 2024 at Hyderabad.
- Following the 'First Annual Regulatory Forum' between the USFDA and the Drugs Control Administration (DCA) of Telangana, the USFDA India Office has begun inviting DCA Telangana inspectors

- as 'observers' for upcoming USFDA inspections in the State via advance email notifications.
- The purpose of this activity is for the agencies to build mutual understanding of each other's inspection processes and share best practices to enhance inspection techniques and procedures.

Spurious Drug Rackets busted by Drugs Control Administration, Telangana:

Drugs Control Administration, Telangana is maintaining a vigilant stance, actively monitoring and detecting the movement of spurious drugs within the State.

On the basis of intelligence gathered by Drugs Control Administration officials, several spurious drug rackets busted in Telangana. During the raids conducted **between December-2023 and November-2024**, spurious drugs worth **Rs. 3.06 crores (from Dec-2023 to December-2024)** seized.

In the year **2024** alone, Spurious Drugs worth **Rs. 2.36 Crores** were seized.

Here are the summarized details:

Date: 4th December, 2023

Details:

Based on intelligence gathered, the DCA raided an unlicensed premises at Machabollaram and detected counterfeit/spurious anti-cancer drugs claimed to be manufactured by a non-existent company, 'Astra Generics Pvt. Ltd.' During the raid, 36 varieties of drugs, including certain spurious anti-cancer drugs, were seized. The total worth of drugs seized was Rs. 4.35 crores, out of which spurious drugs worth Rs. 37.52 lakhs were seized. Kadari Sateesh Reddy is the prime accused in the case.

Date: 29th December, 2023

Details:

Based on intelligence gathered by Drugs Control Administration, Telangana, regarding the entry of spurious drugs into the state from Kashipur, Uttarakhand, a special team conducted raids in Hyderabad on 29th December. The team, assisted by the Task Force, busted a spurious/counterfeit drug racket involving fake antibiotics, hypertension and cholesterol medicines, and analgesics. Stocks worth **Rs. 26 lakhs** were seized.

The spurious drugs were shipped to Hyderabad through the courier company 'Trackon Couriers Pvt. Ltd.' from Kashipur, Uttarakhand, falsely declared as parcels containing 'Machine Parts' by Amar Pharmaceuticals, Ramnagar Road, Kashipur, and delivered to Puvvada Lakshman, Hyderabad.

The seized spurious/counterfeit drugs falsely labeled under reputable companies include - Sun Pharma (Rosuvas 10 Tablets), Glenmark Pharma (Telma H Tablets, Telma 40 Tablets), Aristo Pharmaceuticals (Monocef-O 200 Tablets), Torrent Pharma (Chymoral Forte).

Additionally, DCA officials detected two varieties of antibiotics MPOD-200 Tablets (Cefpodoxime Proxetil and Lactic Acid Bacillus Tablets) and MEXCLAV 625 Tablets (Amoxicillin and Potassium Clavulanate, Lactic

Acid Bacillus Tablets) labeled as manufactured by 'Meg Lifesciences, Sirmour, Himachal Pradesh,' a fictitious/non-existent company.

The accused in the case are Puvvada Lakshman, Pokala Ramesh, and Garapalli Purnachander.

Date: 29th December, 2023 & 30th December, 2023

Details:

DCA, Telangana busted a spurious/counterfeit drugs manufacturing racket at Kukatpally, Hyderabad on 29th December. Rams Pharmaceuticals, located at Moosapet, Hyderabad, was found manufacturing counterfeit Anti Ulcer medicines in the name of a Punjab-based company without a valid drug license, under the guise of being a Food Supplement manufacturer. These counterfeit drugs were then supplied to a wholesale distributor named M/s. Biomedic Pharmaceutical Private Ltd. in Nizamabad.

On 30th December, DCA officials raided M/s. Biomedic Pharmaceuticals Pvt Ltd. in Vinayaka Nagar, Nizamabad, and seized 29,600 capsules of the counterfeit drug Essom-RD (Esomeprazole Gastro-Resistant & Domperidone Sustained Release capsules). These capsules were falsely claimed to be manufactured by QP Phermachem Ltd, F-5, Focal point, (Industrial Area), Sad-he-Majra, Derabassi-141010, and were valued at Rs. 6 Lakhs.

On analysis, Government Analyst reported that the drug content is **NIL** in Essom-RD (Esomeprazole Gastro-Resistant & Domperidone Sustained Release capsules). K. Ranjit Kumar is the prime accused in the case.

Date: 03rd January, 2024

Details:

DCA busted a counterfeit/spurious antibiotics racket involving the shipment of fake antibiotics to the State from Ghaziabad, Uttar Pradesh. DCA seized fake antibiotics worth Rs. 22.95 lakhs during raids at Uppal and Dilsukhnagar, Hyderabad.

Based on intelligence gathered, a special team of DCA kept vigil on various courier offices, including 'Trackon Couriers Pvt. Ltd.' located at Uppal since December 30th, 2023. DCA officials identified the receipt of five cartons from Ghaziabad, Uttar Pradesh on December 30th, 2023, in the name of Puvvada Lakshman, a habitual offender also accused in a spurious drug racket busted by DCA on December 29th, 2023.

DCA officials tracked the courier delivery boy, Suresh Kumar, who proceeded for delivery of the consignment of five cartons on January 3rd, 2024 and followed him to an unlicensed godown at Dilsukhnagar.

During the raid, DCA officials found spurious antibiotic 'Cefoxim-CV Tablets (Cefpodoxime Proxetil & Potassium Clavulanate, Lactic Acid Bacillus Tablets)' of quantity 51,000 tablets worth **Rs. 22.95 lakhs** in five cartons. These tablets were labeled as manufactured by 'Meg Lifesciences, Khasara No. 47/5, Palli Gaon, Sirmour, Himachal Pradesh,' which is a fictitious/non-existent company. DCA officials seized stocks of fake antibiotics during the raid.

Date: 27th February – 29th February, 2024

In a major breakthrough on the illegal manufacturing and supply of spurious/counterfeit drugs, the joint operation conducted by Drug Control Administration, Telangana, Commissioner's Task Force, Hyderabad, and Malakpet Police, dismantled an inter-state network operating from a pharma factory named Nectar Herbs and Drugs, located in Kotdwar, Uttarakhand.

For the first time, a meticulously coordinated inter-state operation named "Operation JAI" was executed by the Drug Control Administration, Telangana, Commissioner's Task Force, Hyderabad, and Malakpet Police. The operation led to the busting of a 'Spurious Drug Manufacturing Unit' located in Kotdwar, Uttarakhand.

Nectar Herbs and Drugs, located in Kotdwar, Uttarakhand, was found to be manufacturing counterfeit drugs (spurious drugs) and distributing them to several states, including Telangana.

Details:

On February 27th, the Drugs Control Administration, Telangana, in collaboration with officers from the Commissioner's Task Force, Hyderabad, conducted a raid at Malakpet based on intelligence regarding spurious drug movement. During the raid, officials seized three cartons containing a total of 27,200 tablets of the spurious antibiotic "MPOD-200 Tablets" worth **Rs. 7.34 lakhs**. These tablets were labeled as manufactured by 'Meg Lifesciences,' a fictitious company.

A person named Aravapalli Satyanarayana was caught selling the spurious drug stocks to Vangari Naveen near Moosarambagh X Roads. Upon interrogation, Satyanarayana revealed that he had purchased the spurious medicines from Gandla Ramulu of Meerpet. Satyanarayana, Naveen, and Ramulu were apprehended.

During further investigation, Ramulu disclosed that the spurious drugs were received from Vishad Kumar of Kotdwar, Uttarakhand. Vishad Kumar, along with Sachin Kumar, manufactures spurious drugs at Nectar Herbs and Drugs, Uttarakhand. Ramulu admitted to placing orders for spurious drugs through WhatsApp calls to Sachin Kumar and Vishad Kumar.

A Joint Action Team, comprising officers from the Drugs Control Administration, Commissioner's Task Force, Hyderabad, and Malakpet Police, was formed. Special teams proceeded to Uttarakhand to trace the manufacturing location of spurious drugs. In a coordinated operation, officers raided Nectar Herbs and Drugs in Kotdwar, Uttarakhand, on February 29th. The officers detected counterfeit Cefixime Tablets IP 200 mg falsely claimed as 'Omnicef-O 200 Tablets.' These counterfeit tablets were falsely labeled as manufactured by Aristo Pharmaceuticals Pvt. Ltd., bearing Batch No. BPF232040, with a manufacturing date of June 2023 and an expiry date of May 2025.

The manufacturing of spurious drugs was being carried out by Sachin Kumar of Roorkee, Uttarakhand. He brought fake labels (pre-printed aluminium foils and other packing materials) of reputed companies to Nectar Herbs and Drugs in Kotdwar, Uttarakhand, in his vehicle along with three workers.

Sachin Kumar stated that the counterfeit labels, including aluminum foils and cartons, were manufactured at Vaishnavi Printers (Vaishnavi Printing Press) in Bhagvanpur, Roorkee, Uttarakhand.

Vishad Kumar, the CEO of Nectar Herbs and Drugs, allowed Sachin Kumar to manufacture spurious drugs at his manufacturing facility for a payment of Rs 35,000/- for 1,00,000 dummy tablets. Bhavana, a worker at Nectar Herbs and Drugs, manufactured dummy tablets with chalk powder upon intimation from Sachin Kumar.

Sachin Kumar, Vishad Kumar, and Bhavana are involved in manufacturing spurious drugs and distributing them across states. Sachin Kumar and Vishad Kumar, the prime accused, were apprehended. Stocks worth Rs. 44.33 lakhs were seized during the raid.

Inter-state arrests were made, and a case was registered against the offenders.

Date: 27th June, 2024:

Raid at Sultan Bazar, Koti:

Spurious Drug - counterfeit version of Vertin 16 Tablets (Betahistine Tablets IP 16 mg), Batch No.: RBIB23006, Mfg. Date: 02/2023, Exp. Date: 01/2026, falsely claimed to be manufactured by M/s Abbott India Ltd., at: Village Bhatauli Khurd, P.O. Baddi - 173205, Dist. Solan, Himachal Pradesh seized at Goel Pharma, Sultan Bazar, Koti.

Raid at Moosarambagh:

Seized Spurious Drugs - counterfeit versions of Vertin 8 Tablets (Betahistine Tablets IP 8 mg), Batch No.: RBIA23009, Mfg. Date: 09/2023, Exp. Date: 08/2026, claimed to be manufactured by M/s Abbott India Ltd., at: Village Bhatauli Khurd, P.O. Baddi - 173205, Dist. Solan, Himachal Pradesh, and counterfeit Vertin 16 (Betahistine Tablets IP 16 mg), Batch No.: RBIB23006, Mfg. Date: 02/2023, Exp. Date: 01/2026, falsely claimed to be manufactured by M/s Abbott India Ltd., at: Village Bhatauli Khurd, P.O. Baddi - 173205, Dist. Solan, Himachal Pradesh at Yashwanth Pharma, Moosarambagh.

Seized spurious drugs worth **Rs. 62,000/-** during the two raids carried out on 27th June, 2024.

Date: 3rd July, 2024:

In a major breakthrough against Spurious Drugs, a joint operation carried out by the SOT Police, Drugs Control Administration, Telangana and Pet Basheerabad Police busted a manufacturing unit in Doolapally, Medchal-Malkajgiri District, which was producing Spurious/Counterfeit drugs of reputed pharma companies Abbott and Cadila as a clandestine activity.

The joint operation led to the busting of a spurious drug manufacturing unit (unlicensed premises) located in Doolapally, Medchal-Malkajgiri District, that was found manufacturing counterfeit versions of Eptoin Tablets (Phenytoin Tablets IP 100 mg) of Abbott and Vasograin Tablets (Ergotamine, Caffeine, Paracetamol, and Prochlorperazine Tablets (1 mg + 100 mg + 250 mg + 2.5 mg) of Cadila Pharmaceuticals and selling them.

Officials seized spurious drug stocks worth 23 lakhs, along with labels, packing materials, and equipment used to manufacture spurious drugs.

Details:

On 3rd July, acting on intelligence gathered, a joint operation was conducted by the SOT Police, Balanagar, the Drugs Control Administration of Telangana, and the Pet Basheerabad Police regarding the manufacturing of spurious drugs as a clandestine activity at an unlicensed manufacturing facility in Doolapally Village, Medchal-Malkajgiri District.

A raid was carried out at an unlicensed premises located at Shed No. 20-17/A/1, Door No. 1-20-6, near St. Martin's Engineering College, Burma Augaiah Nagar, Doolapally, Medchal-Malkajgiri District.

During the raid, officials detected stocks of the following **spurious/counterfeit drugs** manufactured at the said premises:

➤ Eptoin Tablets (Phenytoin Tablets IP 100 mg), Batch No. EPB23012, Mfg. Dt. May-2023 Exp. Dt. Apr-2026 falsely claimed to be manufactured by Abbott Healthcare Pvt. Ltd. Village Bhatauli Khurd, P.O.Baddi, 173 205, Dist. Solan, Himachal Pradesh, India.

➤ Vasograin Tablets (Ergotamine, Caffeine, Paracetamol and Prochlorperazine Tablets 1mg+100mg+250mg+2.5mg), Batch No. JKG523050, Mfg. Dt. Dec-2023 Exp. Dt. Nov-2025 falsely claimed to be manufactured by Cadila Pharmaceuticals Ltd. Industrial Growth Center, SIDCO, Samba-184 121, Jammu and Kashmir.

The manufacturing of spurious drugs was being carried out by **Girneni Gopal Rao**, who belongs to Madhura Nagar Colony, Nizampet, Bachupally.

Girneni Gopal Rao also had counterfeit labels, including aluminum foils and cartons, of products such as Acitrom Tablets (Nicoumalone Tablets), Stemetil MD 5mg (Prochlorperazine Maleate Mouth Dissolving Tablets) of Abbott Healthcare Pvt. Ltd. and BRO-ZEDEX Syrup (Terbutaline Sulphate, Bromhexine HCl, Guaiphenesin & Menthol Syrup) of Dr. Reddy's Laboratories Ltd.

Girneni Gopal Rao and **B. Ramakrishna**, who are the prime accused in the spurious drug manufacturing case, were apprehended by the team. During the raid, officers seized spurious drug stocks worth **23 lakhs**, along with labels and packing materials.

A case has been registered against the offenders in **Crime No. 836/2024** under Sections 338, 336(2), 336(3), 318(4), 340(2), 277, 278 and 49 of the Bharateeya Nyaya Sanhita Act, 2023 at Pet Basheerabad Police Station.

22nd November, 2024:

Drugs Control Administration, Telangana, in a joint operation with the STF, Prohibition and Excise Department, busted a Spurious Drug racket in Hyderabad. The racket involved the shipment of spurious antibiotic tablets from Uttar Pradesh to Telangana through couriers. Narcotic drugs, viz., Fentanyl Transdermal Patches, were also seized during the raid.

Gandla Ramulu, a habitual offender involved in various spurious drug cases in the State, shipped the spurious antibiotics into Telangana from Uttar Pradesh with the assistance of Munishekhar, a resident of Proddutur, Andhra Pradesh.

Spurious antibiotics worth Rs. 6.91 lakhs were seized during the joint operation, and the accused, Gandla Ramulu and Munishekhar, were apprehended as part of the special operation carried out on 22nd November, 2024.

Details:

On 22nd November 2024, the Drugs Control Administration, Telangana, conducted a joint operation with the STF, Prohibition and Excise Department, acting on intelligence about spurious drugs entering the state. A raid at Shree Tirupati Courier Services in Balanagar led to the discovery of shipments from Shree Pharma in Prayagraj, Uttar Pradesh, addressed to Shiv Pharma Distributors, Hyderabad. The drugs were traced to Gandla Ramulu, a habitual offender with several pending cases. Drugs were seized from the premises of a crockery shop located in Karmanghat, where Gandla Ramulu had received the consignment.

Seized drugs included Jakclav-625 Tablets (Amoxicillin & Potassium Clavulanate), Jikpod-CV Tablets (Cefpodoxime & Potassium Clavulanate), Jikcef-LB Tablets (Cefixime & Lactic Acid Bacillus), and Jikcf AZ Tablets (Cefixime & Azithromycin). The names of the firms mentioned on the label, namely 'Manufactured by: Geenac Pharma, Plot No. 582, Raipur, Bhagwanpur, Roorkee, Uttarakhand-247667,' and 'Marketed by: Wellnow Healthcare, Karnal Industrial Estate, Road No. 6, Borivali East, Mumbai-400066,' are found to be fictitious or non-existing firms.

During interrogation, Gandla Ramulu revealed that he had procured the spurious drugs from Prayagraj, Uttar Pradesh, through a person named **Munishekhar of Proddutur**, Andhra Pradesh. He further disclosed that the spurious drugs were intended to be distributed to Kumar of Karimnagar and Bhaskar of Kurnool for sale.

In addition to the aforementioned spurious antibiotics, Narcotic Drugs, viz., Fentanyl Transdermal Patch 50 mcg/hr (Brand Name: FenSpar; Quantity: 12 patches) and Fentanyl Transdermal Patch 50 mcg/hr (Brand Name: THEMIFENT-P; Quantity: 9 patches), were also seized during the joint operation.

The accused, Gandla Ramulu and Munishekhar, were apprehended during the raids carried out on 22nd November 2024.

In connection with the seizure of Narcotic Drugs, a case has been registered at Saroornagar Excise Station vide COR No. 111/2024 U/s 8(c) and 22(c) of the NDPS Act and has been taken up for investigation.

26th November, 2024:

Drugs Control Administration, Telangana, seized a huge stock of antibiotics worth Rs. 1.33 Crores from the manufacturing facility of Jodas Expoim Pvt. Ltd., located in Biotech Park, Karakapatla, Siddipet District.

The seizure was made for exporting products manufactured by other pharmaceutical companies to Russia falsely under their own name and for unauthorized packing of antibiotics.

Based on credible information, officials from the Drugs Control Administration conducted a raid on November 26th at the manufacturing facility of Jodas Expoim Pvt. Ltd., located at Plot No. 55, Phase-III, Biotech Park, Karakapatla, Siddipet District and detected large stocks of antibiotics in the Finished Goods Warehouse, in violation of the Drugs and Cosmetics Act, 1940.

Upon verification, it was found that the antibiotic Ampicillin + Sulbactam 1000 mg + 500 mg Injections, Batch No. JD4479, comprising 38,175 vials, was falsely labeled as manufactured by Jodas Expoim Pvt. Ltd. However, it was actually produced by Indian Genomix Pvt. Ltd., Cherlapally, Medchal-Malkajgiri District, Telangana and was being exported to Russia under false claims.

Additionally, stocks of other antibiotics, such as Amoxicillin 1000 mg + Clavulanic Acid 200 mg, Ampicillin + Sulbactam 2000 mg + 1000 mg, and Meropenem 500 mg, were exported to Russia in October and November 2024 under Jodas Expoim Pvt. Ltd.'s name, although they were manufactured by different companies.

Jodas Expoim Pvt. Ltd. was found to have conducted unauthorized packing of antibiotics.

During the raid, stocks worth **Rs. 1.33 crores** were seized for violating the Drugs and Cosmetics Act, 1940.

Narcotic Drugs / Psychotropic Substances: Detections, Raids, Seizures:

Date: 15th & 16th March, 2024:

Joint operation – Busting of illegal diversion of Narcotic Drugs from Operation Theatre:

Drugs Control Administration, Telangana carried out a joint operation along with:

- TSNAB (Telangana State Anti-Narcotics Bureau),
- Prohibition & Excise Department,
- Commissioner's Task Force, Hyderabad,
- Kushaiguda Police, and
- Jagtial District Police, and busted the illegal diversion of Narcotic and Psychotropic Drugs by Dr. G. Madanmohan, an ENT Surgeon at Manasa ENT Hospital in Jagtial.

Dr. G. Madanmohan illegally diverted Narcotic drugs from the Operation Theatre and sent them to Hyderabad through courier/parcel, thereby supplying them to a drug addict in Sainikpuri.

During the raid, officials detected huge stocks of Narcotic Drugs, including 'VERMOR-15' (Morphine Sulphate Injection IP 15 mg/ml), 'Rumorf' (Morphine Sulphate Injection IP 15 mg/ml), 'Rumorf' (Morphine Sulphate Injection IP 10 mg/ml), 'Rumorf' (Morphine Sulphate Injection IP 15 mg/ml) 'VERMOR-10' (Morphine Sulphate Injection IP 10 mg/ml), Rumorf-CR-30 Tablets (Morphine Sulphate Controlled Release Tablets), and Psychotropic drugs Ozatcel 30 (Pentazocine Injection), 'Mezolam' (Midazolam Injection IP 10 mg), 'LORI' (Diazepam Injection 5 mg/ml), 'Librax' Tablets (Chlordiazepoxide & Clinidium Bromide Tablets), Bupregesic Injections (Buprenorphine Hydrochloride Injection), and Buprigesic Patch (Buprenorphine Transdermal Patch) at the house of a drug addict. Officials seized the stocks.

Dr. G. Madanmohan was arrested by Kushaiguda Police, and a case has been registered under the NDPS Act vide FIR No. 197/2024 at Kushaiguda Police Station. The drug license held by 'Maanvitha Pharmacy,' situated in Manasa ENT Hospital on Gollapally Road, Ashok Nagar, Jagtial, was cancelled by the Drugs Control Administration, Telangana.

Seizure of Drugs of abuse – 3-MMC, Alpha-PiHP: Joint Operation with Prohibition & Excise Department:

Date: 21st March, 2024:

3-MMC, a drug of abuse: Manufacturing site busted in a joint operation carried out by Drugs Control Administration and Prohibition & Excise Department. Stocks worth Rs. 8.99 Crores seized during joint operation.

In a major breakthrough, Drugs Control Administration, Telangana carried out a <u>joint operation</u> along with Prohibition & Excise Department on the basis of an alert from INTERPOL and successfully busted illegal manufacturing of the Psychotropic Substance '3-Methylmethcathinone (3-MMC)' at PSN Medicare Private Ltd. in IDA Bollaram, Sangareddy District.

'3-Methylmethcathinone' which is also known as '3-MMC' or 'Metaphedrone' is a drug of abuse which is circulating on the market and is used recreationally by drug addicts.

During the joint operation, officials seized the stock of quantity 90.48 Kgs of worth Rs. 8.99 Crores.

Date: 22nd March, 2024:

Manufacturing Units of illicit drugs 3-MMC and Alpha-PiHP busted. Stocks worth Rs. 2.33 Crores seized.

The <u>joint operation</u> carried out by Drugs Control Administration, Telangana along with Prohibition & Excise Department successfully busted illegal manufacturing of the Psychotropic Substances 'Alpha-PiHP' at Medchem Labs, IDA Bollaram, Sangareddy District and '3-

Methylmethcathinone (3-MMC)' at Vanamali Organics Pvt Ltd., IDA Mankhal, Ranga Reddy District.

During the joint operation, officials seized the stock of Alpha-PiHP of quantity 2.850 Kgs of worth Rs. 1.19 Crores during the raid at Medchem Labs and stock of 3-MMC of quantity 11.5 Kgs of worth Rs. 1.14 Crores during the raid at Vanamali Organics Pvt. Ltd. Stocks of total worth **Rs. 2.33 Crores** were seized during the joint operation.

'Alpha-PiHP' and '3-MMC' are drugs of abuse which are circulating on the drug market and are illegally used as psychostimulant drugs.

Date: 30th October, 2024:

<u>Joint Operation with Prohibition & Excise Department – Narcotic Drugs</u> – Private Hospitals:

Drugs Control Administration, Telangana carried out a joint operation along with Prohibition & Excise Department and busted a network involved in the illegal procurement, stocking, and sale of Narcotic Drugs and Psychotropic Substances in Hyderabad.

Officers from the Drugs Control Administration, Secunderabad Zone along with officers from STF and DTF of Prohibition & Excise Department carried out a raid at GV Saluja Hospital, Rezimental Bazar, Secunderabad on 30th October, 2024.

During the raid, officials detected huge stocks of Narcotic Drugs, including Fentanyl Injections 100 mcg/2 ml, and Psychotropic Substances, such as Ketamine Hydrochloride Injections 50 mg/10 ml vial, Pentazocine Injections 30 mg/1 ml, Midazolam Injections 1mg/ml (10 mg vial), which were stocked illegally for sale at GV Saluja Hospital without an NDPS licence.

During the investigation, it was revealed that Neha Bhagwath, N/o. Nagpur, Maharashtra, W/o. Sushil Kumar, R/o. Moulali, illegally supplied the aforementioned Narcotic and Psychotropic Drugs to GV Saluja Hospital. Neha Bhagwath is a habitual offender with two previous cases filed against her under the NDPS Act and she was

enlarged on bail in a NDPS Act case in the third week of September-2024.

Officers conducted a raid at the residence of Neha Bhagwath in MJ Colony, Moulali, Malkajgiri, and detected huge stocks of narcotic drugs, including Morphine Injections, Morphine Tablets, Fentanyl Citrate Injections, and Fentanyl Citrate Patches, Pentazocine Injections etc. which were illegally procured and stocked for supply to various unlicensed entities in Hyderabad.

The accused, Neha Bhagwath, confessed that she illegally procured the Narcotic Drugs and Psychotropic Substances from Dinesh of Pioneer Drug House, located at H.No. 164, Plot No. 172, Shop No. 132, 1st Floor, Sridevirathan Complex, Aagyaramdevi Square, Subhash Road, Ganeshpet, Nagpur.

Neha Bhagwath, a supplier of Narcotic Drugs and Psychotropic Substances; Patturi Gopinath, an employee at GV Saluja Hospital; Surender Singh Gusia, an operation theatre technician at GV Saluja Hospital; and B. Srinivas, a pharmacist at GV Saluja Hospital were apprehended on 30th October.

Additional raids are being conducted at several Hospitals in Hyderabad where Neha Bhagwath had illegally supplied Narcotic Drugs and Psychotropic Substances.

A case has been registered vide COR No. 69/2024 dated: 30-10-2024 under the NDPS Act at Secunderabad Prohibition & Excise Station.

Date: 7th and 8th November, 2024:

<u>Joint Operation with Prohibition & Excise Department – Narcotic Drugs</u> – Private Hospitals:

Drugs Control Administration, Telangana carried out a <u>joint operation</u> along with Prohibition & Excise Department and busted illegal stocking and sale of Narcotic Drugs and Psychotropic Substances in private hospitals in Hyderabad, including:

- Bakoban Hospital, Chandrayangutta, Hyderabad, and
- BVK Reddy Hospital, Warasiguda, Boudhnagar, Secunderabad

Huge stocks of Narcotic Drugs and Psychotropic Substances including Fentanyl injections, Ketamine injections, and Midazolam injections were seized during the joint operation.

Based on credible information regarding the illegal possession and sale of narcotic drugs, officers from the Drugs Control Administration, along with officers from the Prohibition & Excise Department, carried out raids at **Bakoban Hospital**, Chandrayangutta, Hyderabad, and **BVK Reddy Hospital**, Warasiguda, Boudhnagar, Secunderabad, on 7th and 8th November 2024.

During the raid, officials detected huge stocks of **Narcotic Drugs**, including Fentanyl Injections 50 mcg/ml ampoules, which were illegally stocked for sale at the hospitals **without an NDPS license**, as well as **Psychotropic Substances**, such as Ketamine Hydrochloride Injections 50 mg/ml vials and Midazolam Injections 1mg/ml (10 ml vial).

Cases have been registered under the NDPS Act at Charminar Prohibition & Excise Station and Musheerabad Prohibition & Excise Station against the accused.

Unlicensed drug manufacturing: Detections, Raids, Seizures:

- □ During raids carried out by DCA in October & November 2023, DCA officers detected unlicensed manufacturing of the drug 'Tizanidine Hydrochloride' at SV Labs Pvt. Ltd, Koyyalagudem Village, Choutuppal Mandal, Yadadri-Bhuvanagiri District along with unlicensed stocking of the drug Amantadine Hydrochloride at the said premises and seized drugs worth Rs. 66 lakhs.
- ☐ In the month of December, 2023, DCA officers detected unlicensed manufacturing of drug 'Dapoxetine Hydrochloride' at Meka Labs, Gaddapotharam Village, Jinnaram Mandal, Sangareddy District and seized the drug Dapoxetine Hydrochloride of quantity 284 Kgs worth Rs. 20 Lakhs.

☐ In the month of January, 2024, DCA officers detected unlicensed manufacturing of the drug 'Diacerein' at Rakshit Drugs Pvt. Ltd., Unit II, Sy. No. 466, Temple Street, Bonthapally Village, Gummadidala Mandal, Sangareddy District and seized the stock of 236 Kgs of the drug 'Diacerein' worth Rs. 50.25 lakhs during the raid.

Seizure of illegally manufactured and stocked APIs worth Rs. 96 lakhs:

On 23rd July, 2024, Drugs Control Administration, Telangana, in a **joint operation** with the Prohibition & Excise Department, busted a godown storing **illegally manufactured and stocked Bulk Drugs (Active Pharmaceutical Ingredients)** at Door No. 3-21, First Floor, Potharam Y-Junction, Muduchintalpally Village, Medchal-Malkajgiri District. The godown belongs to **Aspen Biopharma**.

Kadari Sateesh Reddy of Aspen Biopharma, a habitual offender in several cases with the DCA, was operating the godown where the illegal stocks were detected.

Stocks of drugs, including anticancer, antiviral, antifungal, anticoagulants, antidepressants, etc., worth **Rs. 96 lakhs** were seized during the raid.

Blood Centers – Surprise Raids – Special Drive on 21st February, 2024:

Risk-based inspections were conducted <u>without prior notice</u> at **nine blood centers** on **21**st **February** by special teams formed by the Drugs Control Administration, Telangana as part of Special Drive.

Detected several shortcomings during their raids at the blood banks, including lapses in blood and blood component testing, excessive charges collected by blood banks, inadequate record maintenance, and lack of calibration of certain critical equipment etc.

Departmental Action taken against nine blood centers - Suspended licences of 8 blood centres and cancelled licence of one blood centre.

Special Drive on illegal sale of Habit-forming Drugs – based on inputs from the Commissioner's Task Force, Hyderabad.

Drug Control Administration, Telangana conducted raids as part of a special drive concerning the illegal sale of habit-forming drugs, based on inputs from the Commissioner's Task Force, Hyderabad.

The raids were conducted on several medical shops in Hyderabad for the illegal sale of habit-forming drugs, including Codeine-containing cough syrups, Nitravet (Nitrazepam) Tablets, Restyl (Alprazolam) Tablets, Ultracet Tablets (Tramadol), and Tydol Tablets (Tapentadol), etc.

The licences of twenty medical shops in Hyderabad and Secunderabad zones were suspended, and the licence of one medical shop was cancelled by the Drugs Control Administration for the illegal sale of habit-forming drugs.

Raids at fifteen private medical shops located in Government Hospital premises in Hyderabad, Secunderabad, Warangal, and Karimnagar

Drugs Control Administration, Telangana, on 28th October 2024, conducted raids at fifteen private medical shops located in Government Hospital premises in Hyderabad, Secunderabad, Warangal, and Karimnagar. Several violations were reported, including the possession of Physician's Samples and expired drugs.

Show Cause Notices were issued to the medical shops to initiate appropriate action as per the Drugs Rules.
