Press Release

Drugs Control Administration, Telangana officials raided Iswarya Fertility Center at Malakpet which is running a pharmacy with a 'fake drug licence' and seized huge stocks of medicines worth Rs. 10 lakhs.

Iswarya Fertility Center, Malakpet produced a forged/fabricated drug licence to the officers of DCA during the raid, which is found to be a falsified document.

Brief details are as follows:

Drugs Control Administration Telangana officials, on credible information, raided Iswarya Fertility Center located at D. No. 16-2-741/D/5, Beside T.V. Tower, New Malakpet, Hyderabad. Iswarya Fertility Center is running a pharmacy in the name of 'Iswarya Fertility Services Pvt. Ltd.' with a forged drug licence.

During the raid, Anil Bodasu, Head-Administration of Iswarya Fertility Center submitted a licence document to Drugs Control Administration officers which is confirmed as 'fake', on verification of DCA Telangana drug licence database. The details of the 'Pharmacist' are also found to be fake.

Iswarya Fertility Center, Malakpet is carrying out illegal stocking and sale of medicines without a valid drug licence issued by Drugs Control Administration, Telangana.

During the raid, DCA officials detected huge stock of medicines in the pharmacy which include sex harmones like Estradiol Tablets, Progesterone Capsules, other harmone injections, steroid injections, anti ulcer drugs, antibiotics etc.

DCA officials seized twenty seven varieties of medicines of total worth **Rs 10 lakhs** during the raid.

Assistant Director Smt. D. Saritha, Drugs Inspectors Sri. G. Anil, Sri. B. Govind Singh, Sri B. Lakshminarayana are among the officers who carried out the raid.

	Conditions Of Licence	

Drugs Control Administration, Telangana issues drug licences to pharmacies/medical shops in the State for stocking and selling of medicines as per the provisions of Drugs and Cosmetics Act. Drug licences are issued through Online Drug Licensing System (ODLS) website of DCA, Telangana. Public may verify whether a medical shop/pharmacy holds a genuine licence issued by Drugs Control Administration, Telangana or not through 'Third Party Verification'.

Public may enter the name of the pharmacy or medical shop in the 'search box' under 'Third Party Verification' of ODLS website <u>https://odls.telangana.gov.in/ThirdPartypublicview.aspx</u> and verify the details of the drug licences issued by Drugs Control Administration, Telangana to the medical shop/pharmacy, to check whether the medical shop/pharmacy is authorized to sell medicines or not.
