

GOVERNMENT OF TELANGANA DRUGS CONTROL ADMINISTRATION



Press Note

Drugs Control Administration, Telangana, has been maintaining a vigilant stance, actively monitoring and detecting various offences related to misleading advertisements, price violations, illegal stocking and sale of drugs, and seizing drugs that were falsely manufactured and sold under the guise of 'food products/nutraceuticals'.

From 1st to 21st June, 2024, Drugs Control Administration, Telangana, carried out 20 seizures related to various offences involving medicines.

During the raids conducted from 1st to 21st June, 2024, the DCA seized stocks worth Rs. 4.50 lakhs.

1) Misleading Advertisements:

DCA seized 13 medicines for making <u>misleading advertisements</u> claiming that they treat various diseases/disorders, in contravention of the

Drugs and Magic Remedies (Objectionable Advertisements) Act, 1954, or Drugs Rules (Schedule J).

The Drugs and Magic Remedies (Objectionable Advertisements) Act, 1954, and the Drugs Rules prohibit the advertisement of certain drugs for the treatment of specified diseases and disorders. No person shall participate in the publication of advertisements regarding the diseases or disorders indicated

under the Drugs and Magic Remedies (Objectionable Advertisements) Act, 1954, or the Drugs Rules (Schedule J).

The advertisement of medicines for the treatment of diseases and disorders such as diabetes, fever, typhoid, urinary stones, gall stones, diseases and disorders of the uterus, and disorders of menstrual flow etc. is prohibited under the Drugs and Magic Remedies (Objectionable Advertisements) Act, 1954.

Persons who make misleading advertisements regarding drugs for treatment of certain diseases and disorders are punishable under Drugs and Magic Remedies (Objectionable Advertisements) Act, 1954, with imprisonment which may extend to six months, or with fine, or with both.

2) Price Violations:

Drugs Control Administration, Telangana seized three <u>overpriced</u> medicines – The MRP indicated is very high compared to the Ceiling Price fixed for the product by the Central Government.

The aforementioned products are essential medicines and are under price control as per the Drugs (Prices Control) Order, 2013. The price of these products shall be in accordance with the 'Ceiling Price' fixed by the National Pharmaceutical Pricing Authority (NPPA), Government of India.

Overpricing of essential medicines is a violation under the Drugs (Prices Control) Order, 2013, and stringent action shall be taken as per the law against violators.

3) Seizure of Drugs Falsely Manufactured and Sold as 'Food Products/Nutraceuticals':

During the raids, the DCA seized three drugs that were falsely manufactured and sold as nutraceuticals.

As per the label claim of the products, Zyfer-XT (Ferrous Ascorbate, Folic Acid Tablets), THIANOVA (Thiamine Mononitrate Tablets 100 mg), and Proferron-XT Haematinic Tablets (Ferrous Ascorbate, Folic Acid & Zinc Tablets) are classified as 'drugs' according to the Drugs and Cosmetics Act.

The said products must be manufactured only under a 'drug license' issued under the Drugs and Cosmetics Act, adhering strictly to the 'Good

Manufacturing Practices' (GMP) outlined in Schedule-M of the Drugs Rules. Additionally, it must meet the quality standards prescribed in the 'Indian Pharmacopoeia' (IP) as mandated.

Similar cases of 'drugs' being manufactured under a 'food license' were previously detected by the Drugs Control Administration, Telangana, in November 2023 and January 2024, which were declared as 'spurious' by the Drugs Control Laboratory, Hyderabad, as the content of the active ingredient was found to be 'NIL' (i.e., zero drug) in the said products.

The drugs that are falsely manufactured and sold under a food license are not produced in accordance with 'Good Manufacturing Practices' (GMPs) and often fail to meet the quality standards prescribed in the Indian Pharmacopoeia (IP). Such products pose serious risks to patients' health and may have severe implications.

Manufacturing and selling 'drugs' without a valid 'drug license' is punishable under the Drugs and Cosmetics Act, with imprisonment for up to five years.

4) Raid at a Medical Shop Operating Illegally Without a Drug Licence:

During a raid carried out on 07th June, the DCA seized a large stock of drugs at a medical shop in Mahbubnagar operating illegally without a drug licence.



Seized 65 varieties of allopathic drugs, worth Rs. 1.5 lakhs, including Antibiotics and Steroids during the raid.

The Drugs Control Administration of Telangana issues drug licences to medical shops and pharmacies in the state for stocking and selling medicines as per the provisions of the Drugs and Cosmetics Act. Stocking drugs for sale without a drug licence is punishable under the Drugs and Cosmetics Act with imprisonment of up to five years.

Wholesalers and dealers who supply medicines to illegal medical shops operating without a drug licence are also punishable under the Drugs and Cosmetics Act. Stringent action shall be taken against such wholesalers and dealers. It is mandatory for wholesalers and dealers to ensure that the medical shop or pharmacy holds a valid drug licence before supplying medicines to them.

The public should never buy medicines from 'unlicensed' medical shops. The risks to public health are significantly increased when purchasing medicines from unlicensed and unregulated sources. Medicines should only be purchased from licensed medical shops. Licensed medical shops display "drug licences issued by Drugs Control Administration, Telangana" conspicuously in a prominent place that is open to the public. Selling medicines without a licence is an offence, and medicines purchased from unlicensed premises are likely to be fake products. The public may verify whether a medical shop or pharmacy holds a licence issued by the Drugs Control Administration, Telangana, through 'Third Party Verification'.

The public may enter the name of the pharmacy or medical shop in the 'search box' under 'Third Party Verification' on the ODLS website at https://odls.telangana.gov.in/ThirdPartypublicview.aspx. This allows them to verify the details of drug licences issued by the Drugs Control Administration, Telangana, to the medical shop or pharmacy, ensuring they are authorized to sell medicines.
