

# GOVERNMENT OF TELANGANA DRUGS CONTROL ADMINISTRATION



### **Press Note**

- A) Drugs Control Administration, Telangana seized three overpriced medicines The MRP indicated is very high compared to the Ceiling Price fixed for the product by the Central Government.
  - a) Itralent-200 Capsules (Itraconazole Capsules 200 mg) at Sathupalli, Khammam District.
  - b) ITROCIDE-200 Capsules (Itraconazole Capsules 200 mg) at Jagtial.
  - c) Evalet 2.5 Tablets (Letrozole Tablets IP 2.5mg) at Sangareddy.
- B) In separate events, Drugs Control Administration, Telangana seized certain medicines due to misleading advertisements:
  - STONBURST Capsules, an Ayurvedic medicine, claimed to treat Kidney Stones' seized in Khammam.
  - 2. Kalonji Oil (Black Seed Oil), a Unani medicine, claimed to treat 'Diabetes' seized in Jubilee Hills.

## A) Seizure of overpriced medicines

#### The details are as follows:

During the raids conducted on 26<sup>th</sup> and 27<sup>th</sup> June, 2024 Drugs Control Administration officials **seized three overpriced medicines**: Itralent-200 Capsules (Itraconazole Capsules 200 mg) at Sathupalli, Khammam District,

ITROCIDE-200 Capsules (Itraconazole Capsules 200 mg) at Jagtial and Evalet-2.5 Tablets (Letrozole Tablets IP 2.5 mg) at Sangareddy.

The product Itraconazole Capsules 200 mg sold under the brand names 'Itralent-200 Capsules' and 'ITROCIDE-200 Capsules' and Letrozole Tablets 2.5 mg sold under brand name 'Evalet-2.5 Tablets' are under price control as per the Drugs (Prices Control) Order, 2013 and the price of the products shall be in accordance with the 'Ceiling Price' fixed by National Pharmaceutical Pricing Authority (NPPA), Government of India.

Further investigation shall be carried out and action shall be taken as per the law against all the offenders.

The prices of Essential Medicines shall be in accordance with the Ceiling Prices fixed by the Central Government. Overpricing of essential medicines is a violation under Drugs (Prices Control) Order, 2013 and stringent action shall be taken as per the law against violators.

## B) Seizure of drugs for misleading advertisements:

#### The details are as follows:

Drugs Control Administration, Telangana officials, detected certain medicines circulating in the market with misleading claims on their labels, stating that they treat 'Kidney Stones' and 'Diabetes'. Such claims are in

contravention of the **Drugs and Magic Remedies (Objectionable Advertisements) Act, 1954.** 

Drugs and Magic Remedies (Objectionable Advertisements) Act, 1954 prohibits advertisement of certain drugs for treatment of certain diseases and disorders. No person shall take part in publication of advertisement regarding the diseases/disorders indicated under Drugs and Magic Remedies (Objectionable Advertisements) Act, 1954.


During the special drive conducted on 26<sup>th</sup> & 27<sup>th</sup> June to detect medicines moving in the market with misleading and objectionable advertisements, the following products were detected by DCA officials:

Drugs Inspector, Khammam Urban detected **STONBURST Capsules**, an Ayurvedic medicine, **Manufactured by:** Beryl India Pharmaceuticals, Sonipat, Haryana. **Marketed by:** GlenSmith Labs Pvt. Ltd., Mumbai. The product label bears a **misleading claim** stating that it treats **'Kidney Stones'.** Stocks of the medicines were seized during the raid conducted at a medical shop in Khammam.

Drugs Inspector, Jubilee Hills detected Kalonji Oil (Black Seed Oil), a Unani medicine, Manufactured, Packed and Marketed by: Bharat Unani Pharmacy, 8-4-103/5/B, Plot No. 20, Mailardevpalli IDA, Hyderabad. The product label bears a misleading claim stating that it treats 'Diabetes'. Stocks of the medicines were seized during the raid conducted at a medical shop in Jubilee Hills.

Advertising a medicine for the treatment of 'Kidney Stones' and 'Diabetes' is prohibited under the Drugs and Magic Remedies (Objectionable Advertisements) Act, 1954.

Further investigation shall be carried out and action shall be taken as per the law against all the offenders.

Persons who make misleading advertisements regarding drugs for treatment of certain diseases and disorders are punishable under Drugs and Magic Remedies (Objectionable Advertisements) Act, 1954, with imprisonment which may extend to six months, or with fine, or with both.


