#### **PUBLIC NOTICE: SPURIOUS/COUNTERFEIT DRUG ALERT**

It has come to the attention of the Drugs Control Administration, Telangana, that an online portal <a href="www.minogain.in">www.minogain.in</a>, is offering the following products, which have been found to be 'Spurious/Counterfeit'.


- Minogain 5% Topical Solution (Minoxidil 5% Topical Solution)
- Minogain Shampoo
- Minogain Minoxidil 5% Topical Aerosol
- Minogain Biotin 10,000 mcg Tablets

The products are <u>falsely claimed</u> to be <u>manufactured by Indu Drugs Pvt.</u>
Ltd., 5-5-278/279, Prashanti Nagar, IDA Kukatpally, Kukatpally, Hyderabad,
Telangana 500072, India, and <u>marketed by Minogain Hair Care Pvt. Ltd. 9-B</u>
Typ-2, Prashanti Nagar, Kukatpally Industrial Estate, Kukatpally, Hyderabad,
Telangana 500072,India.

It has been found upon verification that the above products are not actually manufactured by Indu Drugs Pvt. Ltd. Additionally, Minogain Hair Care Pvt. Ltd. has been identified as a non-existent/fictitious firm.

The above products are being falsely claimed by the counterfeiters that they have been manufactured by Indu Drugs Pvt. Ltd., Telangana.

The public is hereby alerted that counterfeit products are also being offered through the Telegram account "Minogain Hair Care" (@minogain).



The counterfeit drugs are manufactured by anti-social elements and pose significant health risks to consumers.

Consumers and healthcare professionals are informed to **STOP USE** immediately and discontinue the use of the above spurious/counterfeit products.

Retailers and wholesalers are directed to **STOP** the sale and distribution of **the following counterfeit products:** 

- ➤ Minogain 5% Topical Solution (Minoxidil 5% Topical Solution)
- **➤** Minogain Shampoo
- Minogain Minoxidil 5% Topical Aerosol
- ➤ Minogain Biotin 10,000 mcg Tablets

DCA is actively working to ensure the removal of spurious drugs from the market.
