PUBLIC NOTICE: SPURIOUS/COUNTERFEIT DRUG ALERT

Sub: Spurious Drug Alert – D-Calcium Pantothenate IP/BP Batch No. 240326M07 - falsely claimed to be manufactured by Xinfa Pharmaceutical Co. Ltd., East of Huafeng Road, South of Beiwaihuan, Kenli Development Zone, Dongying City, Shandong Province, China – Alert issued - Reg.

It has come to the attention of the Drugs Control Administration, Telangana, that a **spurious drug**, D-Calcium Pantothenate IP/BP, Batch No. 240326M07, **falsely claimed** to be manufactured by Xinfa Pharmaceutical Co. Ltd., East of Huafeng Road, South of Beiwaihuan, Kenli Development Zone, Dongying City, Shandong Province, China, is circulating in the market.

The said drug has been found to be counterfeit/fake and was <u>not actually</u> <u>manufactured by</u> Xinfa Pharmaceutical Co. Ltd., located at East of Huafeng Road, South of Beiwaihuan, Kenli Development Zone, Dongying City, Shandong Province, China.

The said drug, which is an Active Pharmaceutical Ingredient (API), does not bear the importer's name and the import license number, both of which are mandatory to be indicated on the label. These are required for any product imported into India, as issued by CDSCO, New Delhi.

Furthermore, every Active Pharmaceutical Ingredient (API) (bulk drug) manufactured or imported in India shall bear a Quick Response code (QR code) on its label at each level of packaging that store data or information that is readable with a software application to facilitate tracking and tracing. The stored data or information shall include the following minimum particulars, namely: Unique product identification code, Name of the API, Name and address of the manufacturer, Batch No., Batch size, Date of manufacturing, Date of expiry or retesting, Serial shipping container code, Manufacturing licence no. or import licence no., Special storage conditions required (if any).

The spurious drug, D-Calcium Pantothenate IP/BP, Batch No. 240326M07, falsely claimed to be manufactured by Xinfa Pharmaceutical Co. Ltd., located at East of Huafeng Road, South of Beiwaihuan, Kenli Development Zone, Dongying City, Shandong Province, China, does not bear a QR code on the label as required by the Drugs Rules.

All stakeholders are hereby alerted about the above counterfeit drug circulating in the market.

The counterfeit drugs are manufactured by anti-social elements and pose significant health risks to consumers.

All manufacturers and dealers are directed to **STOP** the utilization, sale, and distribution of the above spurious drug and to immediately notify the Drugs Control Administration, Telangana, if they come across such a drug.

DCA is actively working to ensure the removal of spurious drugs from the market.

Drugs Control Administration urges the stakeholders to remain vigilant and report any information regarding the distribution or sale of the above counterfeit drug:
