Illegal Sale of Spasmo-Proxyvon Plus Tablets Busted in Nalgonda

A **joint operation** was conducted by **EAGLE FORCE (TGANB)**, **Nalgonda Police**, and the **Drug Control Administration**. The operation successfully busted an illegal network involved in the sale of *Spasmo-Proxyvon Plus* and *Tramadol (Ultra King)* tablets in **Nalgonda District** leading to the **arrest of peddlers, sellers, and 15 consumers**.

Case Details:

On 20.10.2025, based on the credible information, **EAGLE FORCE (TGANB)** and **Nalgonda Police** conducted vehicle checking near Munugode Road, Nalgonda and apprehended **Md. Zabinulla**, S/o Hafeezulla, aged 35 years, R/o Nalgonda, Dist., who was illegally carrying narcotic tablets on a two-wheeler.

Upon interrogation, he revealed that he had become addicted to Spasmo-Proxyvon Plus tablets and had been illegally purchasing and reselling them for the past three months. He procured the tablets from **Venkata Ramana Medical Store, Thorrur (Mahabubabad District)** without a valid doctor's prescription, in violation of the NDPS Act and Drug Control Rules. He used to purchase each strip (8 tablets) for ₹100 and sell the same to local consumers at ₹200 per strip, thereby earning illegal profit.

Several local consumers, including youth and working individuals, were found to be regularly purchasing and abusing these tablets for intoxication. Their statements revealed growing dependence on such opioid-based drugs, highlighting the alarming spread of pharmaceutical drug abuse.

Medical Shop Violation:

Investigation revealed that **Venkata Ramana Medical Store**, owned by **Daram Krishna Sai**, was **illegally selling Schedule H1 drugs** (*Spasmo-Proxyvon Plus* and *Tramadol*) without obtaining valid prescriptions or maintaining statutory records.

The **Drug Inspector** inspected and **seized the medical shop**, along with relevant records and stock, under the supervision of EAGLE FORCE and Nalgonda Police. The licence of the Medical Shop was cancelled.

Items Seized:

- *Spasmo-Proxyvon Plus Tablets: 2,400*
- *Tramadol Ultra King Tablets: 345*
- *Two mobile phones and one motorcycle*

The seized property and arrested persons were handed over to the **Nalgonda I Town Police Station**, and a case was registered as: **Cr. No. 292/2025 U/s 22(C), 27(a), 29 of NDPS Act.**

Tramadol Addiction Overview:

- Spasmo-Proxyvon Plus and Tramadol tablets contain **Tramadol**, a synthetic opioid, which can cause **physical and psychological dependence**.
- **Symptoms of addiction** include tolerance, withdrawal, compulsive use, mood swings, drowsiness, and impaired coordination.
- **Long-term use** may lead to organ damage, hallucinations, and respiratory depression.

- **Withdrawal effects** include restlessness, insomnia, intense cravings, and panic attacks.

All the consumers are being referred to De-Addiction Centre for rehabilitation in accordance with Section 64A of the NDPS Act, 1985, which grants immunity from prosecution to addicts voluntarily undergoing treatment. Their parents and families are being informed and counselled to support the recovery process and prevent relapse.

Public Appeal:

In recent times, several **youth and students have fallen prey to drugs**, leading to crime and social instability. Many families are suffering due to this menace.

The **Telangana EAGLE FORCE** appeals to **youth and parents** to stay vigilant and report any drug-related activities.
