DRUGS CONTROL ADMINISTRATION DEPARTMENT

The Drugs Control Administration, Telangana functions as the regulatory authority entrusted with the responsibility of ensuring the availability of safe, efficacious, and quality medicines in the State.

In furtherance of the Government of Telangana's commitment to safeguarding public health, the Drugs Control Administration has implemented comprehensive regulatory and enforcement mechanisms to ensure that only medicines conforming to prescribed standards are made available to the public.

The year **2025** witnessed intensified regulatory vigilance, enforcement actions, and inter-departmental coordination to address emerging challenges and mitigate public health risks.

The Drugs Control Administration, Telangana remains steadfast in its commitment to proactive surveillance and effective enforcement to detect and prevent offences relating to medicines across the State.

During 2025, the Drugs Control Administration, Telangana conducted a total of 244 seizures for violations of various Acts enforced by the Department and detected 84 sub-standard drugs circulating in the market.


The Drugs Control Administration, Telangana has adopted a proactive and vigilant regulatory approach to continuously monitor, detect, and take

stringent action against violations relating to medicines, with the objective of safeguarding public health.

The Drugs Control Administration, Telangana carried out extensive enforcement activities addressing diverse regulatory violations.

A **summary** of key cases registered by the Drugs Control Administration during the year **2025** for breaches of various Acts enforced by the Department is presented below.

Curbing the Menace of Spurious (Counterfeit) Drugs

The Drugs Control Administration, Telangana has maintained a vigilant and proactive approach in detecting, dismantling, and preventing spurious drug (counterfeit drug) networks across the State. Recognising the serious threat posed by spurious medicines to public health, the DCA intensified surveillance, inspections, and enforcement actions during the year 2025, resulting in the detection and seizure of counterfeit drugs worth several lakhs of rupees.

The spurious drugs detected during these operations included widely used therapeutic categories such as anti-cholesterol medicines, antihistamines, and anti-epileptic drugs, many of which were falsely labelled as products of reputed pharmaceutical companies. Several consignments were found to have been illegally transported from other States and circulated within Hyderabad and other parts of Telangana, indicating organised interstate spurious drug networks.

Detection and Seizure of Counterfeit "Montek-LC" Tablets (18 March 2025)

On 18th March, 2025, based on actionable inputs, the Drugs Control Administration conducted raids at multiple dealers in Hyderabad, leading to the detection of spurious (counterfeit) versions of 'Montek-LC' Tablets (Montelukast Sodium and Levocetirizine Hydrochloride Tablets), falsely claimed to be manufactured by a reputed pharmaceutical company.

During the raids, the suspected stocks were detained, and comparative batch verification was undertaken in coordination with the original manufacturer. Upon examination, the manufacturer conclusively confirmed

that the detained batches were spurious/counterfeit drugs. The seizure marked a significant enforcement action against counterfeit medicines being circulated under the guise of reputed brands.

Detection of Counterfeit "Rosuvas F" Tablets and Arrests (19 June 2025)

On 19th June, 2025, further raids were conducted at multiple dealers in the Inderbagh–Koti area of Hyderabad, resulting in the detection of spurious (counterfeit) versions of *'Rosuvas F 20'* and *'Rosuvas F 10' Tablets* (Rosuvastatin and Fenofibrate Tablets), falsely claimed to be manufactured by a reputed pharmaceutical company.

During these operations, offenders involved in the sale and distribution of counterfeit drugs were apprehended. Arrests were effected in connection with the circulation of spurious drugs.

Detection of Counterfeit "Levipil 500" Tablets and Arrests (July 2025)

In continuation of intensified enforcement, the DCA detected spurious (counterfeit) versions of *'Levipil 500' Tablets* during raids conducted in Secunderabad on 4th July, 2025 and subsequently in Karimnagar on 5th July, 2025. The counterfeit products were falsely claimed to be manufactured by a reputed pharmaceutical company.

These raids led to the seizure of spurious stocks from multiple distributors, and offenders involved in the illegal trade of counterfeit medicines were arrested.

Arrest of Offenders – Zero Tolerance against Spurious Drugs

As part of a firm enforcement strategy, the Drugs Control Administration, Telangana initiated stringent legal action against individuals involved in spurious drug offences. During the year, **four dealers were arrested** in connection with spurious drug cases.

These arrests, undertaken for the first time in the history of DCA Telangana, sent a strong message of zero tolerance towards the manufacture, distribution, and sale of spurious drugs.

The decisive enforcement actions have instilled a strong deterrent effect and significantly curtailed the circulation of counterfeit medicines in the State. These measures underscore the unwavering commitment of the Drugs Control Administration, Telangana to safeguarding public health, protecting patients, and preserving the integrity of the pharmaceutical supply chain.

Coordinated Enforcement Actions against Habit-Forming Drugs, Psychotropic Substances, and Prescription Drug Abuse

The Drugs Control Administration, Telangana has accorded highest priority to curbing the abuse and illegal circulation of **habit-forming drugs and other prescription medicines in the State**, undertaking targeted enforcement actions and special drives to prevent their indiscriminate sale.

Joint Operations with Prohibition & Excise Department to Curb Abuse of Habit-Forming Drugs

In alignment with the vision and firm determination of the Government of Telangana to make the **State drug-free**, the **Drugs Control Administration**, **Telangana** has undertaken sustained and coordinated enforcement actions in close collaboration with the **Prohibition & Excise (P&E) Department**. These joint operations are aimed at curbing the illegal manufacture, diversion, and abuse of habit-forming drugs and psychotropic substances, thereby safeguarding public health and preventing drug abuse in the State.

Busting of Psychotropic Drug Racket – Alprazolam Trafficking (04 June 2025)

On 4th June, 2025, a major joint operation was conducted at Hayathnagar and Moosarambagh areas of Hyderabad, leading to the busting of a well-organised psychotropic drug racket. The operation revealed **illegal shipment of Alprazolam Tablets from Uttar Pradesh to Telangana** through courier services. The racket was operated by an individual with a history of involvement in multiple cases related to spurious drugs.

During the operation, **1.2 lakh Alprazolam Tablets** worth ₹4.32 lakh were seized at a courier agency in Hayathnagar, while additional drugs worth **₹5.21 lakh** were recovered from an unlicensed residential premises at Moosarambagh, Malakpet, Hyderabad. The accused were apprehended by the Prohibition & Excise Department. In total, stocks worth **₹ 9.53 lakh** were seized during this joint enforcement action, demonstrating effective interdepartmental coordination in disrupting interstate drug trafficking networks.

Crackdown on Illegal Diversion of Codeine Cough Syrups (21 April 2025)

On 21st April, 2025, a joint operation by the DCA Telangana and the Prohibition & Excise Department successfully uncovered the **illegal diversion** and sale of Codeine Phosphate Cough Syrups in the Lalapet area of Secunderabad. A woman involved in the illicit sale was apprehended, and three accused were arrested during the operation.

As part of stringent regulatory action, the Drugs Control Administration, Telangana cancelled the drug licences of two medical shops for violations of the provisions of the Drugs and Cosmetics Act, 1940. Further, a case was registered under the Narcotic Drugs and Psychotropic Substances Act, 1985 by the Prohibition & Excise Department. This action reinforced the Government's zero-tolerance policy towards diversion of habit-forming drugs from licensed channels.

Joint Raids on Chemical and Pharmaceutical Units Based on TGPCB Data

The Drugs Control Administration, Telangana, in coordination with the Prohibition & Excise Department, conducted joint raids on chemical and pharmaceutical manufacturing units based on data obtained from the

Telangana Pollution Control Board (TGPCB). The inspections primarily focused on units whose Consent for Operation (CFO) applications had been rejected or were not in force, with the objective of verifying the absence of any unauthorised or clandestine manufacturing activities involving narcotic or psychotropic substances.

These coordinated inspections served as a **proactive deterrent against misuse of industrial infrastructure for illegal drug manufacturing**, in furtherance of the State Government's commitment to preventing drug abuse.

Detection of Designer Drugs / New Psychoactive Substances Manufacturing and Export

During joint vigil and monitoring operations at chemical units and sick pharmaceutical units, the Drugs Control Administration, Telangana, in coordination with the Prohibition & Excise Department, detected the manufacture and export of **Designer Drugs / New Psychoactive Substances** (NPS) by a manufacturing unit located within an industrial area of Telangana.

It was observed that the unit was engaged in the manufacture and export of synthetic psychostimulant substances, primarily to European destinations, under the guise of chemical products. The following four substances were identified during the course of inspections:

- 1. Methylenedioxypyrrolidinohexiophenone (MDPHP)
- 2. Ethylpentedrone
- 3. 2-Methylmethcathinone (2-MMC)
- 4. 2-Methylethcathinone (2-MEC)

These substances are chemically modified analogues of regulated psychotropic drugs and have **no recognised legitimate medical or industrial use.** Although these substances are not presently included in the Schedule of Psychotropic Substances under the Narcotic Drugs and Psychotropic Substances Act, 1985, their abuse potential and associated public health risks are significant.

Further, the possibility of their diversion for domestic consumption within the country cannot be ruled out.

Proposal for Inclusion of Identified Designer Drugs under the NDPS Act

In view of the serious abuse potential of the above substances, their lack of legitimate application, and the growing threat posed by New Psychoactive Substances, the **Drugs Control Administration**, **Telangana has proposed** the inclusion of the following substances in the Schedule of *Psychotropic Substances* under the Narcotic Drugs and Psychotropic Substances Act, 1985, in larger public interest:

- Methylenedioxypyrrolidinohexiophenone (MDPHP)
- Ethylpentedrone
- 2-Methylmethcathinone (2-MMC)
- 2-Methylethcathinone (2-MEC)

These proactive regulatory and enforcement measures underscore the commitment of the Drugs Control Administration, Telanagna, to combat drug abuse, prevent the emergence of new drug threats, and protect public health through robust inter-departmental coordination and policy intervention.

Joint Operations with Police Department

The Drugs Control Administration, Telangana, maintains close coordination with the Police Department to detect and prevent offences relating to the illegal manufacture, stocking, sale, and diversion of narcotic drugs and psychotropic substances. Such **inter-departmental coordination** has been instrumental in identifying instances of **misuse and abuse of prescription medicines**, particularly those with high abuse potential.

As part of special enforcement drives conducted in Hyderabad in coordination with the Police Department, focused action was taken against the abuse of prescription medicines, including cardiac stimulant drugs. Based on information received from the Police Department, officials of the Drugs Control Administration conducted a raid on 17th October at an unlicensed premises located in Namalagundu, Secunderabad. During the raid, stocks of the cardiac stimulant drug Mephentermine Sulphate Injection were detected, which were being illegally stocked and sold for non-medical use, including abuse by gym-goers for bodybuilding purposes.

The coordinated inter-departmental enforcement action underscores the sustained efforts of the Drugs Control Administration to curb the misuse and abuse of **prescription-only cardiac stimulant drugs**, in line with the State Government's commitment to protecting public health and preventing drug abuse.

Oversight of NDPS Drug Manufacturing Units

The Drugs Control Administration, Telangana, in coordination with the Central Drugs Standard Control Organisation, Hyderabad Zone, conducted

unannounced joint inspections at formulation manufacturing units and Active Pharmaceutical Ingredient (API) units across the State holding drug licences for NDPS drugs. These inspections were undertaken to verify statutory compliance and to rule out any illegal manufacture, supply, or diversion of habit-forming drugs, including Tramadol and Codeine, as part of preventive regulatory measures aimed at mitigating the risk of misuse.

Risk-Based Inspections for Strengthening GMP Compliance of Manufacturing Units in Telangana

Risk-based inspections of manufacturing units are being conducted to detect deviations from Good Manufacturing Practices, thereby ensuring the production of quality drugs in the state.

The Drugs Control Administration, Telangana has adopted a robust **risk-based inspection framework** as a core regulatory strategy to ensure sustained compliance with the provisions of the Drugs and Cosmetics Act, 1940 and the Rules made thereunder.

These inspections are triggered both by **DCA Telangana** and are also conducted jointly with the Central Drugs Standard Control Organisation (CDSCO). The objective of this risk-based approach is to ensure strict adherence to Good Manufacturing Practices (GMP), and safeguard the manufacture of quality, safe, and efficacious drugs within the State.

Telangana, being recognised as the **Bulk Drug Capital of India**, contributes nearly **35% of the country's pharmaceutical production** and plays a significant role in global pharmaceutical exports.

In this context, DCA Telangana accords the highest priority to maintaining the credibility, quality standards, and global reputation of the State's pharmaceutical manufacturing ecosystem.

Risk-based inspections are therefore carried out and stringent regulatory actions are initiated wherever deviations from GMP or statutory provisions are detected, reinforcing a strong culture of compliance among manufacturers.

Focused Regulatory Oversight of Liquid Oral Manufacturing Units

In view of international and national concerns relating to the adulteration of cough syrups with toxic contaminants such as **Ethylene Glycol** (EG) and Diethylene Glycol (DEG), the Drugs Control Administration, Telangana has laid special emphasis on liquid oral dosage form manufacturers.


Recognising the serious public health implications associated with such contamination, DCA Telangana has implemented a series of **preventive and regulatory measures to ensure the safety of liquid oral formulations** manufactured in the State.

As an abundant precautionary measure, DCA Telangana issued **public** alerts and "Stop Use" notices in respect of contaminated cough syrups reported in other States, and ensured wide dissemination of these advisories through print and electronic media to safeguard public health. In addition, comprehensive directions were issued to all Enforcement Officers of DCA Telangana mandating focused inspections of liquid oral manufacturing units,

with clearly specified compliance points relating to EG and DEG testing of raw materials and finished products.

Joint Risk-Based Inspections and Industry Sensitisation

Further, risk-based inspections of liquid oral manufacturing units were conducted by DCA Telangana in coordination with CDSCO, and appropriate regulatory actions were initiated in cases of non-conformities, particularly with respect to GMP compliance.

To reinforce preventive compliance, DCA Telangana also conducted sensitisation meetings with liquid oral manufacturers across the State, emphasising strict adherence to quality requirements for critical raw materials such as Propylene Glycol, Glycerine, and Sorbitol Solution, as well as mandatory testing of finished liquid oral products. Manufacturers were clearly informed that any non-compliance would attract stringent regulatory action.

To institutionalise these safeguards, DCA Telangana issued circulars dated 13th October 2025 and 12th November 2025 to all liquid oral manufacturers, detailing mandatory compliance requirements for the manufacture of liquid oral dosage forms. The Department continues to conduct surprise inspections of manufacturing facilities to verify ongoing compliance with these directions, thereby ensuring sustained regulatory oversight and reinforcing the State's commitment to protecting public health through preventive and risk-based regulation.

Risk-Based Sampling to Enhance Detection of Sub-Standard Drugs

The Drugs Control Administration, Telangana strengthened market surveillance during the year 2025 by implementing a **risk-based sampling** strategy aimed at improving the detection of sub-standard drugs across the supply chain. Detailed risk-based sampling directions were issued to field


officers, along with clearly defined **risk indicators for the lifting of samples** from both manufacturing facilities and distribution channels. This systematic approach enabled focused sampling of products and entities posing higher regulatory and public health risks, thereby significantly enhancing the effectiveness of surveillance activities.

As a result of the strengthened risk-based sampling framework, the Drugs Control Laboratory reported **84 drugs** as **Not of Standard Quality (NSQ) during 2025**.

Appropriate regulatory and enforcement actions were initiated against the offenders in accordance with the provisions of the Drugs and Cosmetics Act, 1940 and the Rules made thereunder.

These measures underscore the Department's commitment to ensuring the availability of quality medicines in the State and protecting public health through targeted, data-driven regulatory interventions.

Regulatory Inspections of Drug Licensees to Ensure Compliance with the Drugs and Cosmetics Act, 1940

The Drugs Control Administration, Telangana undertook extensive regulatory inspections during the year 2025 to ensure strict compliance by drug licensees with the provisions of the Drugs and Cosmetics Act, 1940 and the Rules made thereunder. As part of its routine and targeted enforcement activities, the Department conducted a total of 28,816 inspections across manufacturing units, wholesale and retail establishments, medical shops, blood centres, and other licensed premises. These inspections were aimed at ensuring lawful manufacturing, testing and sale/distribution of drugs, and at preventing violations that could pose risks to public health. Upon detection of violations, the Department initiated 5,278 regulatory actions, reflecting a robust enforcement response to non-compliance.

Special enforcement drives were undertaken across the State with a focused objective of curbing the abuse of habit-forming medicines, preventing the indiscriminate sale of antibiotics to address the growing challenge of antimicrobial resistance, restricting the unauthorised sale of MTP/abortion kits, verification of QR Codes - Schedule H2 (300 formulation brands), and stopping the illegal sale of prescription medicines in gyms, particularly drugs misused for bodybuilding and performance enhancement. These targeted drives were designed to address specific areas of public health concern through intensified inspections and enforcement.

In addition to enforcement action, the DCA Telangana adopted a proactive outreach approach by conducting sensitisation meetings with Chemists and Druggists Associations across the State. These meetings aimed

to create awareness among retailers regarding the adverse societal and public health impact of selling **habit-forming drugs and prescription-only medicines** without valid prescriptions from registered medical practitioners. The Department emphasised the legal obligations of licensees and reinforced the importance of ethical dispensing practices.

To further strengthen compliance, the DCA also carried out decoy operations as an enforcement strategy to detect and deter the unauthorised sale of habit-forming drugs and prescription medicines, including cardiac stimulant injections such as Mephentermine. The objective of these operations was to instil a healthy fear of regulatory action among retailers and to discourage violations through effective deterrence.

The Drugs Control Administration, Telangana also maintained close coordination with police authorities to detect and prevent offences involving the illegal diversion and abuse of prescription medicines. This interdepartmental coordination enhanced the effectiveness of enforcement actions and ensured a comprehensive response to violations involving drug abuse and illegal trade.

These sustained inspection and enforcement measures underscore the Department's commitment to regulatory vigilance, public health protection, and strict enforcement of drug laws across the State.

Collaboration with the United States Food and Drug Administration (US FDA)

The Drugs Control Administration, Telangana has significantly strengthened its international regulatory engagement through structured

collaboration with the **United States Food and Drug Administration (US FDA)**. Following the **First Annual Regulatory Forum** between the US FDA and the Drugs Control Administration, Telangana, the US FDA India Office initiated a mechanism to invite DCA Telangana inspectors to participate as **observers in US FDA inspections** conducted within the State.

The primary objective of this collaborative initiative is to build mutual understanding of inspection methodologies, promote the exchange of regulatory best practices, and enhance inspection techniques and procedures. As part of this engagement, officers of the Drugs Control Administration, Telangana have participated as **observers in 13 US FDA—led inspections** to date, thereby gaining valuable exposure to international regulatory standards and inspection practices.

Further strengthening institutional ties, Mr. Greg Smith, Country Director, US FDA India Office, along with his team, visited the Drugs Control Administration, Telangana on 2nd August 2025. During the visit, detailed discussions were held on future strategic collaborations, regulatory capacity building, and initiatives aimed at strengthening inspection systems and enforcement mechanisms.

In addition, the Drugs Control Administration, Telangana was invited to participate in a Video Conference held on 12th August 2025 with a delegation from the White House Office of National Drug Control Policy (ONDCP), led by Ms. Debbie Seguin, Assistant Director for Commercial Disruption and International Relations, along with officials from the US FDA, including Mr. Greg Smith, Director, US FDA India Office. During the interaction, comprehensive discussions were held on the initiatives undertaken by DCA

Telangana to curb the menace of spurious drugs and on regulatory oversight relating to precursors of narcotic drugs, highlighting the State's proactive enforcement measures.

Further engagement took place on 3rd December 2025, when a delegation of senior officials from the US FDA visited the DCA Office in Hyderabad. The visiting delegation included senior representatives from the Office of Global Policy and Strategy (OGPS) and the US FDA India Office. The meeting focused on mutual updates from both regulatory agencies, a review of ongoing collaborative activities, and discussions on future areas of collaboration.

These sustained interactions and collaborative initiatives underscore the commitment of the Drugs Control Administration, Telangana to aligning with **global regulatory best practices**, strengthening regulatory oversight, and enhancing the quality of pharmaceutical manufacturing in the State.

NABL Accreditation and Capacity Enhancement of Drugs Control Laboratory, Telangana

The Drugs Control Laboratory, Telangana, which holds a Certificate of Accreditation from the National Accreditation Board for Testing and Calibration Laboratories (NABL), successfully completed its surveillance audit in March 2025. The accreditation, granted in accordance with ISO/IEC 17025:2017, affirms that the Laboratory conforms to internationally recognised quality standards for testing competence, technical proficiency, and quality management systems.

NABL accreditation is a significant recognition of the Laboratory's capability to generate reliable, accurate, and scientifically valid test results, thereby strengthening regulatory decision-making and enforcement actions under the Drugs and Cosmetics Act, 1940. The accredited status of the Drugs Control Laboratory enhances confidence in analytical outcomes related to drug quality and compliance.

In order to further strengthen regulatory oversight and meet the increasing demands of sample testing, the Drugs Control Administration, Telangana is undertaking infrastructure augmentation through renovation of the second floor of the Drugs Control Laboratory. This expansion is aimed at enhancing the Laboratory's sample testing capacity and analytical throughput, thereby supporting intensified surveillance and enforcement activities.

These initiatives collectively reinforce the State's commitment to ensuring the availability of safe, efficacious, and quality drugs to the public, while strengthening the regulatory capabilities of the Drugs Control Administration, Telangana.

The drugs declared as **Not of Standard Quality (NSQ)** are published on the **public view** portal of the Drugs Control Administration, Telangana, to ensure transparency and to enable public awareness.

Public Awareness Initiatives and Advisories by DCA Telangana

During the year 2025, the Drugs Control Administration, Telangana issued several public advisories to enhance public awareness on critical issues related to drug safety and regulatory compliance.

These advisories focused on creating awareness about **spurious drugs**, **antimicrobial resistance**, **prices of essential medicines**, and the importance of purchasing medicines only from licensed entities. Special emphasis was placed on promoting the "Third-Party Verification" feature available on the Online Drug Licensing System (ODLS) portal of DCA Telangana, enabling the public to verify the genuineness of drug licences held by wholesalers, distributors, and medical shops/pharmacies in the State.

As part of its consumer awareness efforts, DCA Telangana also issued advisories on the verification of QR codes printed on drug formulation brands to help identify genuine products. Further, public advisories were released regarding the display of the designated QR code and Toll-Free Number of the Pharmacovigilance Programme of India (PvPI) to facilitate reporting of Adverse Drug Reactions (ADRs) by the public, thereby strengthening pharmacovigilance and patient safety mechanisms.

In order to widen its outreach and enhance transparency, the Drugs Control Administration, Government of Telangana, launched its **official handle on X (formerly Twitter)** under the name **@DCATelangana** during 2025. This digital platform serves as a medium for sharing the activities and enforcement actions undertaken by the department, disseminating general information for

public awareness, issuing timely advisories on drugs and pharmaceuticals impacting public health, and receiving public grievances and suggestions.

Through these initiatives, DCA Telangana has strengthened public engagement and reinforced its commitment to safeguarding public health through informed participation.
